Dear Friends,

2017 was an exciting year for the Trickey Pond Environmental Protection Association. As always, we used donations like yours to pay for a boat inspector at the public ramp and to fund annual water quality tests performed by the Lakes Environmental Association.

You probably noticed that the public boat ramp was updated at the end of the summer. The new ramp features a storm water basin system that will collect and filter surface runoff. The ramp was upgraded from a 10-foot wide ramp to a 12-foot wide ramp. The parking and turnaround have been improved. While we are excited that the ramp is now designed properly to protect our waters, we must recognize that the improved ramp may increase public boat traffic on the pond. The TPEPA remains vigilant that the boat ramp is a prime entry point for invasive species to be brought into our pond. This potential for increased boat traffic makes our mission to raise money for full-time inspectors for our 2018 summer season even more urgent.





In 2017, 78% of total money spent by the TPEPA was used to pay boat inspectors at the public boat ramp. 17% of money spent paid for LEA water testing.


