DEAR TRICKEY POND FRIENDS,

Reflecting on 2021 the TPEPA and all who support us have much to be proud of. Through the combined efforts of our board members and the donations from our supporters the TPEPA was able to make substantial gains in protecting Trickey Pond in this, our 15th anniversary year.

Accomplishments include:

- Funding 1070 boat inspections, an 18% increase over 2020
- Receiving a \$2000 Maine DEP Invasive Cost Share Grant
- Addressing four erosion sites using Storm Water Compensation Funds
- Gaining approval of our 10 year Watershed Based Protection plan by Maine DEP
- Winning an EPA 319 Grant to address erosion issues identified in our watershed survey

As a donor funded non-profit organization we rely primarily on the contributions of the property owners around Trickey Pond. Currently, about 49% of the property owners donate to the TPEPA on an annual basis. Maintaining this level of funding, with a goal of reaching higher participation rates remains our focus. Increased usage of the public boat ramp and increased development in the watershed both indicate that our work in protecting Trickey Pond must be sustained moving forward.

2021 was also a year marked by collaboration. We are most grateful for the expertise and support provided by Lakes Environmental Association, Maine DEP and Cumberland County Soil and Water Conservation District.

Thank you to all who support our mission to protect and preserve the natural beauty of Trickey Pond.

FINANCIAL OVERVIEW


TPEPA is a registered Maine 501 (c)(3) non-profit organization.


REVENUE

In 2021 TPEPA revenue came from three sources: \$17,949 in donor contributions, a \$2,000 State of Maine DEP Grant and a \$500 appropriation from the Town of Naples.
