DEAR TRICKEY POND FRIENDS,

The Board is pleased to report that TPEPA continues to make strides in our mission to protect Trickey Pond and its watershed. Through the combined efforts of board members and through the donations of our supporters, the TPEPA was able to make substantial gains in protecting Trickey Pond in this, our 16th anniversary year.

Accomplishments include:

- Funded 705 hours of boat inspections
- Awarded a \$2000 Maine DEP Invasive Cost Share Grant
- Completed year one of two year EPA 319 Grant to address non-point source pollution in the watershed
- Assumed financial responsibility for the boat wash station at the public launch

As a donor funded non-profit organization we rely primarily on the contributions of the property owners around Trickey Pond. In 2022, approximately 43% of the property owners surrounding Trickey Pond donated to the TPEPA. We continue to reach out to all property owners with a goal of increasing participation.

As a small, all volunteer lake association we are most grateful for the expertise and resources provided to us by Lakes Environmental Association(LEA), Maine DEP and Cumberland County Soil and Water Conservation District (CCSWCS). LEA remains instrumental in managing the Courtesy Boat Inspector program at the public launch and in conducting the water testing. CCSWCD and Maine DEP provide the leadership for the EPA Grant work. Many thanks to them and to all who support our mission to protect and preserve the natural beauty of Trickey Pond.



REVENUE


In 2022 TPEPA revenue came from four sources: \$18,266 in donor contributions, \$950 in memorial contributions, a \$1500* State of Maine DEP Grant and a \$500 appropriation from the Town of Naples.





EXPENSES

In 2022 93.6% of funds expended went directly towards protecting Trickey Pond.
