Plants are being offered at direct wholesale costs as a convenience to Trickey Pond watershed residents to encourage native plant vegetation for water quality protection. Coordination efforts for this is through the Trickey Pond Watershed Protection Project which has been funded in part by the US Environmental Protection Agency through grant funding from Section 319 of the Clean Water Act, administered by the Maine Department of Environmental Protection. Staff time and volunteer coordination are through Cumberland County Soil and Water Conservation District (CCSWCD) and the Trickey Pond Environmental Protection Association. Additional partners include Portland Water District, the Town of Naples, and Lakes Environmental Association.

Plants are not guaranteed survival upon planting. Estimated total cost may vary depending on whether substitutions have been made and if 6 or more plants of a particular species are ordered (cost would be less). CCSWCD will send an invoice with final balance within 2 weeks of plant arrival. Some properties may qualify for up to \$100 in grant funds on top of the wholesale discount depending on assumed benefit to Trickey Pond and/or assistance with installing plants depending on volunteer support available: Please check with Martina Witts if you are interested for more information.

Please let us know if you wish to order trees or if there is a specific native plant you are interested in that is not listed.

Permits are required for any property planting more than 50 plants on a 100 foot shoreline and within 25 feet of the shoreline (or 25 plants on a 50 foot shoreline) and if any planting will be done with machinery. We can assist in obtaining needed permitting at no cost. Please let us know if this assistance is needed.

Plants will be available for pick up in early July. Shipping costs from the wholesale provider to the Naples area will be covered by the 319 grant project.
